## ITA GENERAL BODY MEETING SUMMARY

On Saturday December 16<sup>th</sup> at 1:30 PM in Berlin Temple the ITA held its Annual General Body Meeting and Election. The meeting had been moved from the 9<sup>th</sup> of December due to inclement weather. Approximately 40 individuals were in attendance. We believe that the General Body Meeting is a critical forum for providing input to the ITA leadership and strongly encourage members to attend future meetings.

**Pankaj Desai** (ITA Vice President & Trustee) welcomed the Membership, outlined the meeting agenda and introduced **Rina Patel** (2017 Election Committee Chair). She then introduced her fellow Election Committee Members, **Surendra Gambhir** and **Ramesh Gupta** (Trustee). She provided a short summary of the new election process, describing the additional criteria and vetting implemented in order to ensure that Trustee Candidates are individuals that have made significant contributions to the organization and are planning to continue to contribute. She then introduced the Trustee Candidates: **Nilang Dalwadi**, **Chetna Giyanani**, **Kavita Gupta**, **Anoo Joshi**, **Danny Saparia**, and **Naylesh Shah**. Each candidate discussed their personal backgrounds, past participation and planned future contributions to the ITA. One of the candidates, **Ramesh Viswanathan** (Trustee), was unable to attend the meeting as a result of the GB meeting date change. As there were only 7 eligible candidates and 7 open positions, balloting was not required. On behalf of the Election Committee, **Rina Patel** declared the candidates as having been elected to the Trusteeship.

**Pankaj Desai**, thanked the Election Committee and welcomed the new ITA Trustees. He also thanked the retiring ITA Trustees: **Bhavesh Patel**, **Sangeetha Rashatwar**, **Surendra Sheth** and **Praveen Garg** for their many years of service and contribution. He also specifically recognized **Harshad Patel**, who was in attendance, for being the ITA's longest serving Trustee with 23 years of tenure.

**Pankaj Desai**, then delivered the President's Update on behalf of **Lalit Patel** (President & Trustee) who was absent due to severe case of the flu. Lalit Patel's update started by reminding everyone of the key aspects of the ITA's mission: to maintain a place of worship and center for cultural activities; to provide a platform for religious and cultural activities through which the Hindu religion and philosophy may flourish; and to be a charitable and educational organization. He then highlighted the positive collaborative environment that the ITA has been operating under for the past year and the resulting progress that is making the organization stronger. He then enumerated the key accomplishments of 2017: completion of the next-door Pujari residence; revision of the ITA By-Laws; reengagement of the Advisory Board; continuing growth in new events; increased attendance at existing events such as Navratri, Holi, Dussehra and Mata Ki Chowki; and increased participation in children's programs such as Balvihar whose enrolment is over 270. He then discussed the key priorities for 2018 which include: fully implementing the new By-Law provisions; evaluating need for and completing of the parking lot; improving the documentation of policies and procedures; and continuing to improve member participation. In concluding the President's remarks, **Pankaj Desai** extended his appreciation to all of the leaders, volunteers, donors and members that have supported the organization in the past year.

**Shobna Daga** (Treasurer & Trustee) provided a summary P&L of the ITA for the fiscal year ending June 30th, 2017. She indicated that the ITA continues to be financially healthy and generate a modest surplus. Navratri, donations and other programs continue to grow but are partly offset by increases in expenses such as health care costs. **Gopal Patel** (Investment Committee Chair & Trustee) provided a brief update on the investment portfolio. He indicated that returns for the 12 months ended June 30th were 11.8% and that YTD returns were 12.2%. Both return metrics were in line with expected returns given the ITA's balanced equity and fixed income portfolio.

**Divyakant Parikh** (Temple Manager & Trustee) provided an update on the Temple facilities. He stated that the Pujari residence is complete and both Pujari's have started living in the house. He also indicated that Berlin Township had approved the Parking Lot plan and that the ITA was awaiting final approved drawings. Once in hand, ITA planned to seek bids from contractors. He anticipates that the parking lot construction will start in spring and be completed by summer. He acknowledged that project is taking longer than originally anticipated due to challenges from the township as well as shortage of volunteers with the right construction experience. He also highlighted the new chandelier in the Puja Hall and thanked the generous donors for their contribution.

**Charu Sheth** (Trustee) provided an update on ITA events for 2017. She indicated that she was very happy this year with the growth in volunteer participation and member attendance. In addition to another successful Navratri, she highlighted that 650 people attended Dussehra, 350 attended Holi and over 600 attended Mata Ki Chowki. She also discussed programs that were expanded this year which included Tulsi Vivah, Chaitri Hawan, and celebration of all days of Ganesh Chaturthi Utsav. In the area of children's programs, she talked about the growing success of the children's Janamashthami, Diwali, Vasant Panchmi and Navratri events. She individually thanked all volunteers, pujaris and Darshan Committee members that helped make each of the individual events possible and encouraged everyone to attend future events.

**Samir Patel** (Trustee) provided a short update on the key changes in the new By-Laws: 1. Change in Trustee Elections; 2. New Organization Structure; and 3. Additional Accountability Measures and Protections. He also provided a quick update on key programs. The Balvihar Program, overseen by **Malathi Shankar**, continues to grow with record enrollment and attendance. This year the program added more audio-visual tools in the classroom and launched a student leaders program in which Balvihar graduates return to help teach younger students. He further discussed the new Head Start Speaker Series, which is being overseen by **Parth Chauhan**, that is focused on helping our youth be more successful. He also discussed Vinita Ganju's (Trustee) new initiative to help Senior's deal with life issues.

**Pankaj Desai**, concluded the prepared portion of the meeting by thanking all attendees and opening the meeting for comments and questions.

**ITA GENERAL BODY MEETING SUMMARY (continued)**

Questions & Comments

**Danny Saparia** asked why the financial presentation had been shifted to June 30<sup>th</sup> cycle. The Trustees explained that the change was required by the new By-Laws. The goal was to better align the financial budgeting with the start of our major activities such as Navratri and Balvihar. It also allowed the Trustees to present full year results at the GB meeting. Trustees further noted that our financial year for tax and filing purposes remains December 31<sup>st</sup>.

**Rina Patel** asked how the cost of the parking lot was going to be funded. The Trustees indicated that a portion would be funded from the CY2018 operating budget and a portion would be funded from the ITA’s investment account. The Trustees would not be in a position to be more specific until the final bids were received.

**Harshad Patel** requested that the Trustees develop ethics and moral code of conduct for Trustees to better safe guard the institution. Trustees indicated that they would take his recommendation under consideration and explained that a formal conflicts policy would be developed.

**Mahendra Toprani** asked how the space freed up by Shuklaji’s move to Pujari’s residence would be utilized. The Trustees indicated that in the near term the space would be used for meeting and other general needs. However, the Trustees plan to also explore whether a small elevator can be constructed in that space.

**Bhulabhai Bhakta** voiced concerns that not enough attention was being focused on services to seniors and that too much attention was being placed on children’s programs. He also felt that ITA should dedicate more resources to seniors that lacked sufficient family support. Trustees indicated some new initiatives for seniors were already in the works and that they are open to working with the Senior Group on additional programs that are within the ITA mission and did not create liability concerns.

**Jaysukh Sheth** expressed his support for the new Advisory Board structure and appreciation for the opportunity to be more engaged in the ITA. Trustees thank him for his support.

Once all questions were answered and comments were heard, **Pankaj Desai** concluded the meeting.

## **ITA GENERAL BODY MEETING & TRUSTEE ELECTION REPORT**

**Dear Membership,**

**I, Rina Patel am the election committee chair. The other members are: Ramesh Gupta (current BOT) and Surendra Gambhir, Ex-president of SJ Senior Citizen's Group.**

**The election committee, is an independent body as defined by our By-Laws that the election committee is not subject to be influenced from the general community be it whether they are from advisory board, past trustees and as such. Given the magnitude of the responsibility and the tasks given, the election committee strives to discharge its responsibility in an impeccable manner, one members would find fair and unbiased.**

**Trustees under the new by-laws have a much greater set of responsibilities and commitment requirement's. The new by-laws also set a more rigorous eligibility criteria for Trusteeship. The goal of these changes was to ensure that Trustees would be filled by dedicated and unconflicted individuals. As a result the EC's role in this election cycle was more involved and important.**

**Committee vetted the applicants with much stringent parameters then we have in the past in qualifying them. These parameters included:**

**Verifying Member Eligibility by substantiating records with ITA accounting data.**

**Further, Eligibility requires these candidates to have been involved in temple operations for the past few years. We verified information provided by candidates with various temple management.**

**We requested each candidate to provide detail Bio in reference to their Professional background, their Mandir areas of expertise that they possess that can be used to contribute to benefit the Mandir in such as Mandir governance, program management and execution, Fund raising, Membership Relations etc. Requested candidates to attest to and sign off on the temple Political Participation Policy**

**In fact as a result of this process two candidates, withdrew there applications because they did not feel they could fulfill the requirements of Trusteeship.**

**The Election Committee completed its review process and found the following candidates eligible for elections for 2018-20 term:**

**Last but not the least, our Mandir should be the pivot of our Hindu community, a place where the young meets the old, the old makes way for the young, and the young steers the community in a direction that dynamically adjusts to the current aspirations of the second generation Hindus. Fortunately and finally, this has come to pass as we see involvement of the next generation in our temple management.. 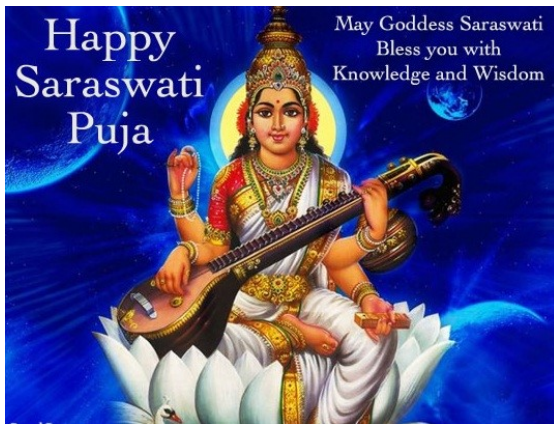
